Thermus Species Richard Sharp 2012-12-06 There is considerable interest in thermophile microorganisms, in their environments, their ability to survive at temperatures which normally denature proteins, but more importantly, as a valuable resource for bio technology. The first

reported isolation of *Thermus* by Tom Brock was in 1969. This initiated the present era of thermophilic research with the realization that where liquid water is available, there may be no limits to the temperature at which microorganisms can grow. Considerable research into the ecology, physiology, metabolism, and thermostable enzymes of thermophiles has led to their evaluation for a range of industrial and commercial processes.
